At present there are 66 vacancies of SCPOs existing in Kollam City and Kollam Rural (Kollam City-33, Kollam Rural- 33). Hence the following promotion and transfer and posting of SCPOs is ordered with immediate effect.

Sri.B Prasannan, CPO Q 5273 who was included in the select list of CPOs published vide reference cited was not given promotion in due turn since he was under suspension during the period. Now he has been re-instated into service. Hence he is promoted as SCPO in the scale of pay of Rs.27800-59400. He will be on probation for a period of one year on duty within a continuous period of two years. His seniority in the cadre of SCPO will be between Sri.Sudarsana Babu, SCPO Q 5271 and Sri.Thaha Koya, SCPO Q 5274.

Sri.Suresh Kumar, Q 5311 of Chavara PS, who stands promoted as SCPO and posted to Kollam Rural as per reference 2nd cited is posted back to Kollam City, in the existing vacancy of SCPO.

Subsequently, the following senior most CPOs, who are included in the finalised select list published vide reference 3rd cited and who were temporarily promoted against the notional vacancies of SCPOs as per reference 4th cited , are provisionally promoted as SCPOs in the scale of pay of Rs.27800-59400 and posted against the existing vacancies of SCPOs in Kollam City and Kollam Rural. They will be on probation for a period of one year on duty within a continuous period of two years.


