

They will be the junior most CPOs in Kollam District and their seniority in this district will be reckoned only with effect from the date of joining duty in this district/ as per the prevailing rules. They are not eligible for joining time and TA since the transfer is ordered at their request. Before relieving them, a written undertaking to the effect that they are willing to be transferred to Kollam District on loss of seniority may be obtained from them and the same may be pasted in their Service Books, duly attested. Details of PR, if any, pending against them also may be intimated to this office. Due to administrative exigencies, DPCs concerned are requested to relieve the transferees urgently. **If they do not report within 15 days from the date of issue of this order, their transfer order to KCP Kollam will be cancelled on presumption that they are unwilling to join and the next senior most applicants will be considered instead of them.**
