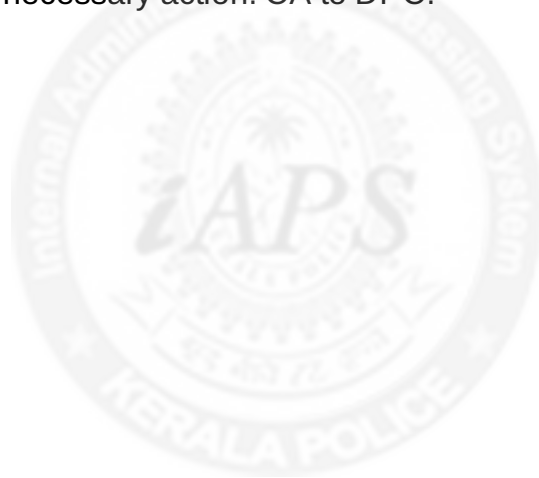
Those who are posted in Kollam City will submit their options for posting within 3 days. Controlling officers concerned will relieve the Rural transferees immediately and report compliance.
