Sub : Police Estt- Supplementary select list of CPOs fit for promotion as SCPOs for the year 2018- finalised- Orders issued-reg

Read : This office proceedings No.A1-23966/2015/QC dated 05.03.2018

Order No : A1-23966/2015/QC Dated. 14-03-2018

A provisional list, containing 145 CPOs fit for promotion as SCPOs (GE) for including in the supplementary select list for the year 2018 was published as per reference cited. The provisional list was prepared based on the ranking in the existing finalised seniority list and the senior most 145 qualified CPOs were included in the list for filling up the vacancies of SCPOs arising during 2018. Unit Heads concerned were requested to communicate the list among the CPOs concerned and to forward objections, errors, omissions, if any, within 7 days. Accordingly, complaints have been received from the following police personnel and modifications/ corrections are made in the final list, based on their merits, as follows.

- 1) Sri,Lekshmanan K, CPO Q 4600 and Sri.Rajeshkumar VR, CPO Q 5053 submitted applications for granting them eligible service benefits as they have attained 50 yrs of age. This was verified and found true. They have not qualified the General HC test. But they are eligible for inclusion in the select list according to the provisions contained in GO(Ms) No.248/2012/Home dated 24.09.2012. Their juniors have already been promoted as SCPOs. Hence they are included in the final list as SL.Nos 1 & 2 respectively.
- 2) Sri.Jayaprakash, CPO Q 6031 complained that he joined in Kollam district as senior to Sri.Vijayan Pillai, CPO Q 6032, but is not included in the provisional select list. The complaint is found genuine. His rank in the CPO seniority list is 974 and hence he is included in the finalised list as Sl.No.69 (between Q 6030 Sudhakaran and Q 6032 Vijayan Pillai)
- 3) Sri.Shooja M, CPO Q 5603 submitted a complaint that his rank in the seniority list is 1037 but is wrongly placed in the list. This was examined and found true. Accordingly, he is placed in the final list as Sl.No.123 (between Sri.Parameswaran Unni,Q 5602 and Sri.Radhakrishnan, Q 5605)
- 4) Sri.Sathyarajan, CPO Q 5519 submitted complaint against non-inclusion of his name in the list. His rank in the seniority list is 1019 and eligible for inclusion in the select list. Hence he is placed in the finalised list as Sl.No.107 (between Q 5517 James and Q 5520 Alexander)
- 5) Sri.Joy, CPO Q 5433 (Sl.No.49 in the provisional list) complained that he is immediate



senior to Sri.Dinesh, Q 5434, but is wrongly placed in the list as SI.No.49. This complaint was found true and hence he is placed in the final list as SI.No.47 (between Q 5431 Sri.Vikraman Nair and Q 5434 Sri.Dinesh).

6) Sri.Ansar Khan, CPO Q 5501 complained that the CPOs from SI.No.65 to 72 in the provisional list are his juniors, but they are wrongly placed in the list as his seniors.

7) Sri.Sunil Kumar, CPO Q 5855 submitted a complaint that some police personnel who joined Kollam district after his date of advice,ie, 20.08.1997 are falsely included in the provisional list which is against rule and requested to retain his seniority above them.

These two complaints are related to seniority disputes among police personnel which is now under consideration of the Hon'ble High Court of Kerala and the Hon'ble Kerala Administrative Tribunal. The present select list is prepared based on the existing finalised seniority list. The complaints of Sri.Ansar Khan and Sri.Sunil Kumar can be examined only according to the decision of the Hon'ble Courts of Justice in the seniority disputes. Hence these complaints are kept in abeyance till the disposal of various petitions/OA's/Appeals pending before the Hon'ble High Court of Kerala and the Hon'ble Kerala Administrative Tribunal.

8) Sri.Yesudasan, CPO Q 6399 complained that he is not included in the list. His rank in the seniority list is 1233. Police personnel up to rank 1063 only are included in the present select list. Hence the complaint of Sri.Yesudasan, CPO Q 6399 is devoid of merits and hence rejected.

No other complaints have been received. Hence, the supplementary select list of CPOs fit for promotion as SCPOs for the year 2018 is finalised and published as below.
